Cheniere Partners Announces Offering of \$1.35 Billion Senior Secured Notes due 2028 by Sabine Pass Liquefaction, LLC

Houston, Texas - February 27, 2017 - Cheniere Energy Partners, L.P. ("Cheniere Partners") (NYSE MKT: CQP) announced today that its wholly owned subsidiary, Sabine Pass Liquefaction, LLC ("SPL"), intends to offer, subject to market and other conditions, \$1.35 billion principal amount of Senior Secured Notes due 2028 (the "SPL 2028 Notes").

SPL intends to use the net proceeds from the offering (after deducting the initial purchasers' commissions, estimated fees and expenses and incremental interest during construction related to the SPL 2028 Notes) to pay capital costs in connection with the construction of Trains 1 through 5 of the Sabine Pass Liquefaction Project. In connection with the offering, SPL will reduce commitments on a ratable basis under its credit facilities (the "2015 SPL Credit Facilities") of approximately \$1.2 billion. The SPL 2028 Notes will rank pari passu in right of payment with all existing and future senior secured indebtedness of SPL, including borrowings under the 2015 SPL Credit Facilities, its outstanding senior secured notes due 2021, senior secured notes due 2022, senior secured notes due 2023, senior secured notes due 2024, senior secured notes due 2025, senior secured notes due 2027, senior secured notes due 2028, senior secured notes due 2029, senior

The offer of the SPL 2028 Notes has not been registered under the Securities Act of 1933, as amended (the "Securities Act") and the SPL 2028 Notes may not be offered or sold in the United States absent registration under the Securities Act or an applicable exemption from the registration requirements of the Securities Act.
